There is no major change in characteristic wise with this revision.

For example, a product manufactured in August or before with an old AWS classification designation may be shipped together with a product manufactured in September or after with a new AWS classification designation.
 - (3) For a same order, certificates of inspection in old and new classification may be issued. For example, the certificate corresponding to a product manufactured in August or before is attached with an old AWS classification designation, and the certificate corresponding to a product manufactured in September or after is attached with a new AWS classification designation, and both certificates are issued for the same order.
